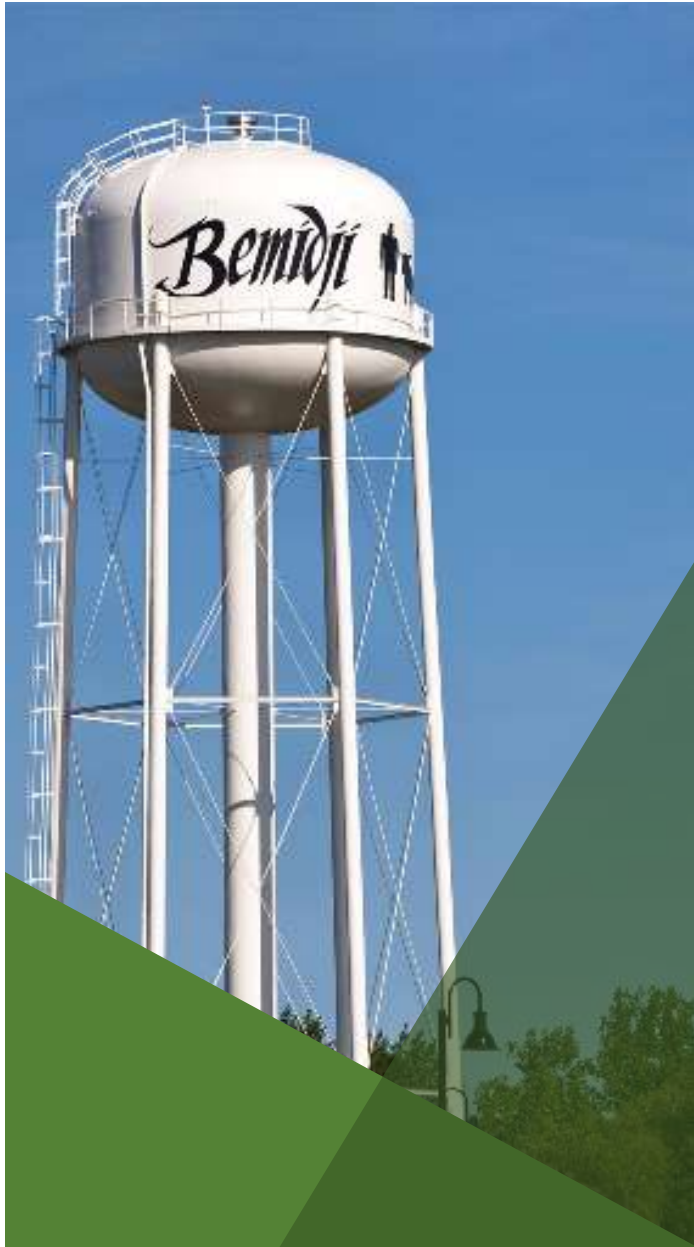

# Adoption Resolution

## Resolution No. 2019-07

### RESOLUTION ADOPTING AN UPDATED COMPREHENSIVE PLAN FOR THE GREATER BEMIDJI AREA (CITY OF BEMIDJI AND NORTHERN TOWNSHIP)

**WHEREAS**, the Greater Bemidji Area Joint Planning Board (“GBAJPB”) is the governing body for planning and zoning purposes within the City of Bemidji and Northern Township; and

**WHEREAS**, the GBAJPB has the authority under Minnesota Statutes, section 462.355 to engage in comprehensive planning activities and to adopt and amend a comprehensive plan; and

**WHEREAS**, the GBAJPB has adopted a comprehensive plan and has undertaken a process, with the assistance of Houston Engineering, Inc., to develop an updated comprehensive plan; and

**WHEREAS**, the GBAJPB has engaged in a thorough updating process with various opportunities for the public to provide input, including an open house the GBAJPB and Steering Committee held on November 20, 2018; and

**WHEREAS**, the Greater Bemidji Area Joint Planning Commission (“GBAJPC”) held a public hearing on February 28, 2019, after providing proper notice, regarding the updated comprehensive plan and voted to forward it to the GBAJPB with a recommendation that it be adopted; and

**NOW, THEREFORE, BE IT RESOLVED**, that the Greater Bemidji Area Joint Planning Board hereby adopts the updated comprehensive plan dated March 13, 2019 as the official Comprehensive Plan of the Greater Bemidji Area, which replaces the previous comprehensive plan and is effective immediately.

Adopted on the 13<sup>th</sup> day of March, 2019 by at least a 2/3 vote of all the members of the Greater Bemidji Joint Planning Board.

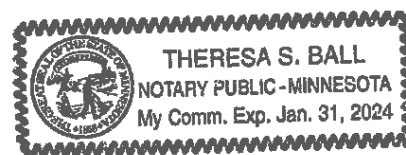
